- Leading Games Team during pre-production and the shoot, taking place across multiple countries

Senior Trials Producer | I'm a Celebrity: GMOOH!, Lifted Jun 2025 – Dec 2025

- First member of UK Editorial Team to arrive in Australia and start overseeing Art builds from September
- Produced the Live Trial, *Cocktails of Cruelty* - the first Live Trial to be featured on the show since 2020
- Rehearsed Live script more than six times, to ensure movements were clear and that timings were hit
- Ran Celebrity Cyclone alongside Games Exec, and managed crew to ensure that everyone had a specific role
- Worked with external SFX company to set up 'meltdown' smoke and explosion for *The Jungle Doomsday Vault*

Missions Producer | The Celebrity Traitors, Studio Lambert Jan 2025 – May 2025

- Led brainstorming and contributed to the development of Missions for the first BBC Celebrity series
- Attended recces and produced location decks, which outlined gameplay and logistical considerations
- Produced Trojan Horse opener, and liaised with Art, SFX, Cameras and H&S to ensure a smooth shoot
- Responsible for Mission paperwork (inc. Gamesheets and Scoresheets) and distributing to wider crew

Trials Producer | I'm a Celebrity: GMOOH!, Lifted Jul 2024 – Dec 2024

- Produced 7 x Bushtucker Trials, including *The Vile Volcano* and *Shock Around the Clock*
- Completed a handover of 14 x further Bushtucker Trials when new Trials Producers started on the series
- Responsible for producing critter and 'messy supply' master docs, keeping track of supplies across the series
- Led 10+ person Art meetings, and solely responsible for interviewing and choosing to employ two Runners

Missions Producer | The Traitors, Studio Lambert Jan 2024 – Jun 2024

- Led brainstorming and contributed to the development of Missions for both BBC and NBC series
- Produced *Riddle Me This* Mission for NBC, and prepped another 'Wet Weather' contingency
- Managed the responsibilities of an AP and delegated tasks alongside providing support where needed

Trials Producer | I'm a Celebrity: GMOOH!, Lifted Jul 2023 – Dec 2023

- Produced 8 x Bushtucker Trials, including *No Time to Cry* and *Down the Tubes*
- Mocked up ideas in PowerPoint and pitched them in development to get over 20 x Trials signed off
- Worked with external suppliers to produce moments never seen on series before i.e. laser maze

Forward Planning Producer | Hot Mess Summer, Naked TV May 2023 – Jun 2023

- Worked with PSC crews on location in Greece as 8 x cast attempted to run a real-life bar
- Wrote nine-page 'Bar Handbook' with our on-screen Bar Manager, along with 2 x event briefs
- Built relationship with real-world Bar Manager so we could manage music, customers, and stock

Task Producer | Couple to Throuple, Naked TV Jan 2023 – Mar 2023

- Worked with Series Producer to develop and produce 9 x 'Relationship Sessions'
- Managed the responsibilities of two Assistant Producers and two Researchers on location in Panama
- Wrote 7 x Task Briefs that were sent to the Channel (and all crew) to ensure everyone was on the same page

- Produced 12 x Bushtucker Trials, including *Who Wants to Look Silly on Air* and *Boiling Point*
- Briefed cast (and answered questions) on camera to ensure they understood Trials gameplay
- Managed complex relationship with Sony to gain permission to use the *Who Wants to be a Millionaire* licence
